APPENDIX MAIN CONTENTS OF THE CONTRACT

(Attached to Resolution No 18/NQ - BOD dated September 23, 2025).

- 1. Subject of the Contract: PetroVietnam Coating Joint Stock Company signed the Contract Pipe Coating Service Block B O Mon PC1 Gas Pipeline Project" between PetroVietnam Coating Joint Stock Company sign with Thien Nam Offshore Services Joint Stock Company.
- 2. Contract Term: 150 days from the contract signing date between the two parties (including Saturdays, Sundays, and public holidays).
- 3. Contract Value: 848,823,234,381 VND (Eight hundred forty-eight billion, eight hundred twenty-three million, two hundred thirty-four thousand, three hundred eighty-one dong), VAT included.
 - 4. Contract Type: Fixed unit price contract.
 - 5. Payment Term:

- For 28" Pipes:

- + Advance Payment: Party A will advance Party B 10% of the value of the 28" pipe coating service including pipe coating service, anode installation service and transportation service within 45 days after Party A receives valid documents.
- + Payment by delivery: Party A will pay Party B up to 90% of the total value of coated steel pipes for each delivery. Instalment 1: 1,500 Coated Pipes; Instalment 2: 3,000 Coated Pipes; Instalment 3: The remaining quantity of 28" Coated Pipes of the Contract within 45 days after Party A receives valid documents from Party B.
- + Settlement for 28"ch pipeline: Party A will pay up to 100% of the Contract settlement value to Party B within 45 days after completing the completion dossier and Party A receives valid dossier from Party B.

- For 18" Pipes:

- + Advance Payment: Party A will advance Party B 10% of the 18" pipe coating value (before VAT) including pipe coating service; anode installation and transportation service within 45 days after Party A receives valid documents.
- + Payment: Party A will pay Party B up to 90% of the total value of the coated steel pipe within 45 days after Party B delivers the product to Party A and when Party A receives valid documents from Party B.
- + Settlement: Party A will pay up to 100% of the Contract settlement value for the 18" pipeline value to Party B within 45 days after completing the completion documents and Party A receives valid documents from Party B.
- 6. The law applicable to dispute resolution is the Law of the Socialist Republic of Vietnam, dispute resolution will be resolved by arbitration at the Vietnam International Arbitration Center (VIAC) located at the Vietnam Chamber of Commerce and Industry (VCCI) in Ho Chi Minh City.
